Outside Vendor Guidelines

Concession space will be outdoors, and all applicants must furnish their own display, tents, etc.

1. The number of concessions within each category will be limited, and fees will be refunded to those not accepted.
2. Spaces will be assigned on arrival at the fairgrounds. Please arrive early to gain easy access to your space. Check in with the Festival Representative at the red and white spaghetti tent.
3. Returning concessionaries will be given priority.
4. The concessionaire is responsible for supplying any needed electrical extension cords.
5. Please submit a picture and diagram of concession setup.
6. The Italian Festival Committee sells Italian Dinners, Italian Pizza, & Italian Sandwiches. For this reason, concessionaires will not be allowed to sell these items. Unusual food items will be allowed.
7. Proof of \$1,000,000 liability insurance must be submitted with application for those vendors with rides and/or activities.
8. The committee reserves the right to accept or deny applications for concessions.
9. Setup time is from 12 p.m. - 5 p.m. on Thursday, May 7 and 10 a.m. - 12 p.m. on Friday, May 8. All concessions must be removed after closing of Festival on Saturday, May 9. Early departure is unacceptable, except for emergencies.
10. Security will be on property from Thursday night until Saturday afternoon.
11. Vehicle parking will be at an assigned area—**No vehicles other than those that are an integral part of the actual booth will be permitted on the site.**

The McAlester Italian Festival Foundation, Inc., the Pittsburg County Regional Exposition Authority, or the City of McAlester will not be liable for damage or theft of merchandise or any other property during participation at the Festival.

The deadline for cancellation is April 24, 2026. After this date booth fees will be forfeited. Your cancelled will serve as confirmation. We hope to see you there!!
